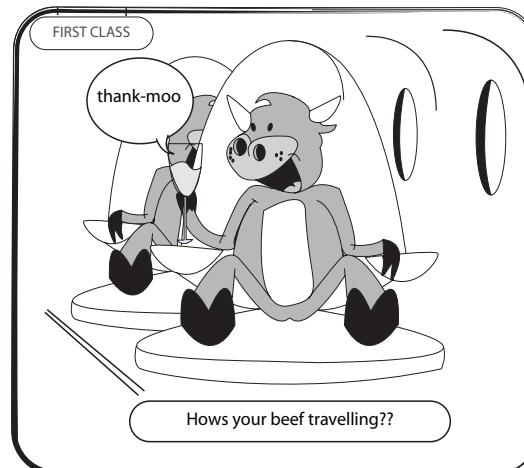

## Background

truckCare is a quality management program especially developed for livestock transporters. It is fully auditable and was put together by a pilot group of livestock transporters in South Australia. The program is built around the quality assurance principles contained in international standards and also uses hazard analysis of critical control points.

The program is aimed at raising awareness, introducing and implementing a quality management system which can be audited by customers, or by an externally qualified auditor. truckCare can then be integrating with customers or road transport quality assurance programs.

## What does it cost?

### *New truckCare membership joining fees as at-*

- For member of a State LTA \$660 (GST incl.)

## Audit Timings & Charges

**Audit Timings** – After an operator's entry audit, compliance audits are undertaken at 6 months, 24 months from date of entry audit and then every 24 months thereafter.

**Sticker Charges** – \$5.00 per sticker (GST inclusive)

**Annual Fee Charges** – The annual fees are outlined above. For new operators joining the program the annual fee for the first 12 months is included in the joining fee.
